RULES AND REGULATIONS OF THE SOCIETY:

1. Name of the Society:

The Society shall be know as National Environment and Education Development.

2. Location of the Office;

The Regd. Office shall be located at Sri Rama Colony and the field office will be located at Thonam, Salur Constituency.

3. Category of Membershop:

- 1. Member ship of the Centre shall consist of those persons subscribing to athe idea of the center, charter members are those who have signed the Memorandum of Associaton. Ordinary members are those who have been sponsored by two members of the center and when member ship has been approved by the governing body.
- 2. Admission fee and annual subscription:

Any member who is internding to become a member has to pay an admission fee of Rs.5/-(Rupees five only) and also all members has to pay an annual subscription of Rs.1/- (Rupees one only) per persion of the center.

4. ANNUAL GENERAL BODY MEETING OF THE CENTRE;

The annual meeting of the General Body as shall be called once a year by the secretary in consultation with the President. Three weeks notice shall be given and the agenda shall be sent to members 10 days before the meeting.

An extraordinary General Body meeting may be called by the President and shall be called on receiving written request from 2/3(Two thirds) of the membership of the society. Only the business for which the meeting is called shall be discussed.

The President shall proceed all meetings of the center or in the event of his absence, the Vice President of the center may act as chairman for conducting that particular meeting or in the absence of the Vice President also, any member of the center can be elected to act as Chairman for conducting that particular meeting.

The Annual General Body meeting of the center shall be held within three month of the close of the financial year and normally on the third Saturday March each year. As audited statement of account of the centree and draft budget for the following year will be laid before the General Body for its approval with such clarifications as may be sought of the General Body.

The Quorum for the annual meeting shall be one fifth of the membership peovide that in a subsequent meeting held after adjournments due to lack of a quorum, no quorum shall be required.

In the annual meeting of the society voting shall be by persons and not by proxy.

5) Such a proposal will be carried only if it is supported by at least two third of the members of the General body.

14.ALTERATOINS:

No alteration shall be made in the Memorandum of association of in the articles of association of the center which are for the time be in force except in accordance with the provisions of the Andhra Pradesh Registration Act. No amendment or alteration shall be made in the Memorandum of Articles of Association unless it is voted by three fifths (3/5) of the members present at a meeting convened for the purpose and confirmed by three fifth of the members present at a second special meeting.

15.WINDING UP:

On the passing of the resolution for the winding up of the center the Secretary shall take steps to give effect to the same.

Any surplus remaining after satisfaction of all debts and liabilities of the center shall be made over to some other society having similar objects or allied to the center as may be determined by the votes of the majority of the members presents at the time of dissolution.

16.CERTIFICATES.

a) Certified that the association is formed with no profit motive and commercial activity is involved in its working.

6. PROJECT CONSULTANT:

He is an Honorary advisor to the Centre and will render useful help in guiding the center in the policy matters and extension activities.

7. OFFICE BERERS:

They are the responsible persons towards doing the activities of the society which the executive committee entrusted them.

8. POWERS AND FUNCTUIONS OF THE GOVERNING BODY:

a) a report on the activities of the center governing Body shall be presented to the General Body of the Center.

b) The Governing Body shall appoint a programme co-ordinator in a full time and salary basis to be responsible for the implementation of all decisions taken by it and to look after the day to day work of the Centre.

c. The Governing body must meet at interval of not more then six months.

9. QUORUM:

Two thirds of the total members for General Body meeting and two third for executive body meeting . No quorum is necessary for the attachment of aims and objectives.

10. ACCOUNTS:

true accounts shall be kept of all some of money received and expanded by the center and the matters in respect of hich such receipts and expenditure take plac, and of the property, credit and liabilities of the center. And subject to responsible restrictions as to the time and manner of inspections the accounts shall be open the inspection of the members, Once at least in every year the accounts of the center shall be examined and to correctness and the balance sheet and income and Expenditure account as curtained by one or more properlyu qualified auditor or auditors

11. SUSPENSION:

In case of death, resignation or retirement of the member of the Governing Body, or in the case of a member being hold by a competent authority or by a 2/3 majority of the Governing body to benefit to hold the post as member, such vacancy of Vacancies shall be filled by a simple majority of the governing body in case of draw the president shall have casting vote.

12.LEGAL MATTERS.:

any suit or other legal proceedings on behalf of the center and the secretery shall have to power to sign all pleadings petitions written atatments and other papers of documents in connection with such proceedings

13. AMENDMENTS:

- 1) The center shell have the right ot and , to alter or amend those rules and regulations.
- 2) A proposal for such addition, amendment or alteration at least three members of the Executive committee of the center.
- 3) Such a proposal may be considered either at the annual general meeting of the cenatre or at a meeting specially convened and for that purpose
- 4) Such a proposal will be notified to all members of the center by register post at least three weeks before the date of the meeting.


